This canine is being sold as a companion dog and there will be no consideration for breeding.

The Breeder/Seller will retain the AKC papers on the individual canine until proof of neuter/spay has been supplied to Breeder/Seller. The Buyer agrees to have said canine neutered/spayed before said canine reaches the age of 6 months but not prior to the canine reaching the age of four months. Upon receipt of said proof, Breeder/Seller will forward the registration papers to Buyer at the address given above.

Buyer agrees to furnish Breeder/Seller with any change of address, telephone number or email address should it change from that stated above.

If at any time, FOR ANY REASON, Buyer does not want or cannot keep said canine, said canine **MUST** be returned to Breeder/Seller or Breeder/Seller **MUST** approve a new home **IN WRITING. THIS CANINE IS NOT FOR RESALE OR PLACEMENT WITHOUT WRITTEN CONSENT FROM BREEDER/SELLER.**

This canine is guaranteed against any genetic defect. Should any genetic defect be pronounced by two qualified vets Breeder/Seller must be notified in writing. Breeder/Seller will replace this canine at any time Buyer so desires, and a replacement puppy is available from Breeder/Seller's next litter. The original puppy does not have to be returned to Breeder/Seller unless Buyer so desires. However, if Buyer does not wish to keep the original canine, it MUST be returned to Breeder/Seller at Buyer's expense before Breeder/Seller replaces said canine.

If a situation arises where a veterinarian recommends that this canine be put to sleep for any reason, Breeder/Seller will be first notified and reserves the right to obtain a second opinion at Breeder/Seller's expense. If the opinion of Breeder/Seller's veterinarian does not confirm the opinion of Buyer's veterinarian, the Breeder/Seller reserves the right to take back said canine without a replacement .

Buyer agrees that this canine will be a house dog, will NOT be chained outside, will NOT live outside, will be maintained in a fenced yard, will NOT be allowed to run loose without proper supervision, that all vaccinations and heart worm medication will be administered on the proper schedule as determined by Buyer's veterinarian and that this canine will be maintained in healthy, sanitary and comfortable conditions.

A deposit of \$350.00 is due at the signing of this contract. This deposit is fully refundable if the bitch selected to produce this litter does not have live puppies or if a puppy of the buyers desired sex choice is not available.

Buyer agrees to have this canine tattooed with canine's AKC number and/or micro chipped before the age of six months, and have the chosen form of identification registered with the appropriate identifying group such as Home Again or AKC. Buyer agrees to notify Breeder/Seller of the identification chosen and supply Breeder/Seller with the appropriate identification number(s).

This agreement is in the accordance with the laws of the State of Connecticut. Upon signing this agreement, both parties agree that they have read and fully understand said agreement.
