

# SHOW SALES AGREEMENT

This contract pertains to the following described male/female KEESHOND/WHIPPET:

This agreement is made between Heather L. Myers, dba CARA KEESHONDEN & WHIPPETS, hereinafter referred to as "breeder/seller", and

Hereinafter referred to as "buyer".

The purchase price of this canine is \$ \_\_\_\_\_, with buyer agreeing to the following stipulations:

1. A co-ownership will be maintained until the championship has been achieved on this canine. If buyer is not able to achieve this within \_\_\_\_\_, with reasonable attempts to show this canine, said canine will be returned to breeder/seller at a time designated by breeder/seller and shown by breeder/seller (or agent) with buyer paying expenses.
2. The canine will be x-rayed and stifles checked by a qualified veterinarian, the x-rays will be certified by OFA and the results discussed with breeder/seller before said canine is used in a breeding program. If breeding should take place before the OFA age of two (2) years, and over the age of one (1) year, the canine will be preliminary x-rayed and stifles checked. The x-rays will be certified by OFA and the results discussed with breeder/seller before it is in a breeding program. No canine sold as show/breeding stock shall be bred to any other canine who is not designated as PHPT NEGATIVE by either testing or dissent. NO FEMALE SHALL BE BRED BEFORE THE AGE OF TWO (2) YEARS. A copy of the OFA certificate will be sent to breeder/seller for their records. This canine will only be used in a breeding program with x-rayed "good" or "excellent" breeding stock and only those of championship quality, this been proven in the show ring or discussed with breeder/seller of this canine.
3. This canine is NOT for resale or placement without written consent from breeder/seller.
4. If a male, and used at stud, this canine will be bred according to the CARA KEESHONDEN & WHIPPETS STUD CONTRACT. CARA KEESHONDEN AND WHIPPETS will retain unlimited stud services to this canine for bitches owned, co-owned or leased by them, but not to exceed 2 services per year. If a female, this canine will be bred in accordance with the "Breeder's Code Of Ethics" of the Keeshond Club Of America. All offspring that are to be sold as show dogs, will be sold with the same or equal stipulations as this agreement, or as "companions" with the same stipulations as the CARA KEESHONDEN & WHIPPETS Companion Sales Agreement.
5. One show picture (8 x 10) will be furnished to breeder/seller.

6. Final decisions of any kind relating to said dog/bitch will be made by breeder/seller in cases where a dispute arises. If this agreement is broken by buyer in ANY way, or if ANY condition stipulated herein is not met, Buyer agrees to pay breeder/seller \$3,500 in liquidated damages for causing damage to breeder/seller and causing breeder/seller to be in conflict with the parent club and the KCA Breeder's Code Of Ethics and/or AKC. Breeder/seller agrees to the following stipulations:

1. This canine is of sound show and breeding quality.

2. Should the dog not meet the standards of the buyer, one of the following considerations will be made in regards to buyer/breeder/seller/canine:

A. The breeder/seller will refund the purchase price should the canine be returned within 10 days, at buyer's expense.

B. The buyer may agree to a replacement canine in lieu of money. The original Canine will be returned to breeder/seller for placement at buyer's expense. If this is agreed upon, this agreement must be in writing.

C. The breeder/seller will refund the difference between "show price" and "pet price" with the buyer returning the papers to breeder/seller until proof of neuter/spay is furnished to breeder/seller and a Companion Sales Agreement is signed. Papers will then be returned to buyer.

D. Should none of the above be a working agreement, the canine will be bought back for 1/2 the purchase price, with shipping being handled equally by both parties.

3. Breeder/Seller agrees to sign off this canine as co-owner upon completion of said canine's Championship.

BUYER UNDERSTANDS THAT IF AT ANY TIME FOR ANY REASON BUYER DOES NOT WANT OR CANNOT KEEP THIS CANINE THAT IT MUST BE RETURNED TO BREEDER/SELLER OR BREEDER/SELLER MUST APPROVE IN WRITING ANY HOME TO WHICH SAID CANINE MIGHT GO.

By signing herein below, buyer indicates that he/she has read and fully understands the CARA KEESHONDEN & WHIPPETS SHOW SALES AGREEMENT, the CARA KEESHONDEN & WHIPPETS STUD AGREEMENT and the Keeshond Club Of America Breeder's Code Of Ethics.

This Agreement is in accordance with the laws of the State of Connecticut.
